

# TELENİTY İLETİŞİM SİSTEMLERİ SAN. VE TİC. A.Ş. DATA CONTROLLER APPLICATION FORM

## 1. General Description

The Law on the Protection of Personal Data numbered 6698 (“KVKK”) stipulates certain rights to personal data subjects (“Applicant”) on the processing of personal data as per Item 11 of the Law on the Protection of Personal Data.

The application form has been prepared to determine your relation with **TELENİTY İLETİŞİM SİSTEMLERİ SAN. VE TİC. A.Ş.** (“TELENİTY”), fully identify your personal data processed by **TELENİTY** (if any), and to respond to your application accurately and within the legal time frame. To ensure the safety of your personal data and prevent unlawful data transfer, **TELENİTY** may require additional information for identification and authorization. The Applicant will be deemed responsible for providing inaccurate and/or outdated information or submitting unauthorized applications.

As per Item 7 of the Communiqué on the Principles and Procedures of Applications to the Data Controller, any written response to the Applicant not in excess of ten pages is free of charge. For any pages in excess of ten pages, 1 Turkish Liras per page may be charged. If the response is submitted in a CD, memory stick or other recording media, the cost for such media may be charged to the Applicant.

## 2. Scope of the Right to Apply within the Framework of Item 11 of KVKK

Applicant may apply to **TELENİTY** to request the following:

- 1) To learn if personal data is processed,
- 2) To request information on the processing of personal data, if any,
- 3) To learn the purpose of processing personal data and if they they were processed according to such purposes,

- 4) To learn domestic and international third parties that personal data is transferred to,
- 5) To request the correction of any personal data not processed accurately or completely and to request the notification of such corrections to any third parties receiving such data,
- 6) To request the deletion, destruction or anonymization of personal data originally processed in accordance with the KVKK and other relevant legislation, but are no longer required to be processed, and to notify any third parties receiving such data of deletion, destruction or anonymization,
- 7) To object to any detrimental effect due to the exclusively automated processing of data,
- 8) To request compensation for any damage resulting from the unlawful processing of personal data.

### 3.ApplicationMethod

As per the first paragraph in Item 13 of the Law on the Protection of Personal Data ; applications relating to such rights shall be submitted in written and signed form or by any other method established by the Board for the Protection of Personal Data ("Board").

In this framework, written applications can be submitted by printing this form:

In person by the Applicant,

Via notary public,

Via registered electronic mail (KEP) address, using secure electronic signature, mobile signature or

By sending an e-mail via the electronic mail address of the Applicant previously notified and registered in our system.

Below is specific information on the written application channels to submit written applications.
